

## TERMS AND CONDITIONS

### **“EXCLUSIVE PRIVILEGE FOR HSBC PREMIER CUSTOMERS” PROGRAMME**

---

Customer is advised to note that participating in the programme shall mean that Customer has read, understood and accepted these Terms and Conditions.

#### **1. PROGRAMME INFORMATION**

- 1.1. The “Exclusive Offer for HSBC Premier Customers” (“**Program**”) is available for all branches of HSBC Bank (Vietnam) Ltd. (“**HSBC**” or “**The Bank**”) at Ho Chi Minh City, Binh Duong, Hanoi and Da Nang, taking effect from **25 May 2023 until further notice**. (“**Program Period**”).
- 1.2. HSBC employees are not allowed to participate in this Program.
- 1.3. HSBC Premier World MasterCard<sup>®</sup> credit cardholders, who refuse the reward, submit a cancellation request or the card is cancelled due to any reason, will be disqualified.
- 1.4. The Program applies to the following customers: (i) Existing Premier customer of HSBC (“**Existing Premier Customer**”); and (ii) meet the conditions of the Program during the program period (hereinafter collectively referred to as “**Eligible Customers**”).

#### **2. PROGRAMME DETAILS**

##### 2.1 Program conditions

###### 2.1.1 An individual customer, who:

- a) is successfully identified as an existing Premier Customer with a Premier Account; and
- b) Also an active primary HSBC Premier World MasterCard<sup>®</sup> Credit Card; and
- c) Qualifies Premier Total Relationship Balance (“**TRB**”) qualification with the average TRB in the quarter of at least VND 1 billion or foreign currency equivalent at board rate.

##### 2.2 Offers:

- 2.2.1 Eligible Customers will receive 01 redemption code for complimentary green fee at applicable golf course/quarter (“**Golf Privilege**”), and 01 redemption code for complimentary fast track service at applicable airports/quarter (“**Fast Track Privilege**”).

## 2.2.2 General terms of Offers

- a) For Joint Account, for both demand deposit account and Term Deposit account, the offer will be applied to main account holder only during the Program Period
- b) Customer must maintain the minimum average Total Relationship Balance of VND 1billion in the quarter, or foreigner currency equivalent, in the quarter in accordance with the Program conditions to enjoy the offers.
- c) This program shall not be combined with other promotions. In the event where there's more than one (01) promotion being held for the same product, Customer has the right to choose the promotion which Customer would like to join.

2.2.3 To redeem the code, Eligible customers must contact HSBC Premier Concierge (24/7) at (084 28) 3824 0503 subject to followed term and conditions.

2.2.4 The Bank will notify redemption code(s) to eligible customers through their registered email address, with the Bank, by 25th of the first month of each quarter. The first notification EDM will be sent out on 25th of July 2023.

2.2.5 The Bank is not responsible for the failure of the notice, if the Customer has not provided or updated their correct email address.

2.2.6 Redemption codes are non-transferable nor exchangeable between privileges nor converted to cash. All codes will expire after 90 days, from the issuance date.

## 2.3 Offer redemption process:

2.3.1 **Golf Privilege:** Applied for participated golf course as defined in Appendix A (“**List of Participating Golf Courses in the Program**”) of this T&C.

- a) The face value of the redemption code is equivalent to the published price of green fee for one (01) player at **The Participating Golf course in the Program** at time of booking
- b) Advanced booking is required to utilize the golf privilege: at least 3 days prior to the playing time.
- c) Booking is only to be done via calling HSBC Premier Concierge (24/7), as mentioned in article 2.2.3. Eligible customers cannot utilize the complementary green fee if booked directly with the golf course.
- d) Acceptance/change of golf booking is at the discretion of **The Participated Golf course in the Program** and is subject the availability of tee.

- e) Eligible customer(s) are required to make payment by HSBC Premier Visa Platinum Debit Card or HSBC Premier World MasterCard® for (but not limited) green fee of guests (if any), other fees including but not limited to buggy, caddie, locker, and insurance in accordance with regulations of **The Participated Golf course in the Program**.
- f) Cancellation or amendment must be made via HSBC Premier Concierge (24/7), as mentioned in article 2.2.3 and minimum 72 hours prior to tee-off time. Cancellation or amendment made within 72 hours prior to tee-off time or No show shall be counted as a completed redemption.
- g) Maximum 2 times of amendment to a confirmed booking made no later than after 72 hours prior to tee-off time shall be acceptable. Amendment includes change of tee-off time/date and/or change in number/names of guests
- h) There will be no rain check.
- i) The Golf Privilege is not applicable to redeem during Vietnam 's official public holidays
- j) HSBC is not a golf service provider; customer must comply with each Golf Course's Terms and Conditions of Service Use. For any questions or complaints related to this service, Eligible customers need to contact each of the Golf Course directly for solution.

2.3.2 **Fast Track Privilege:** Applied for participated airport as defined in Appendix B ("**List of Participating Airports in the Program**") of this T&C.

- a) The redemption code is valid for a complimentary 'fast track' service at **The Participating Airports in the Program**, including but not limited to, support of customer clearance, private access to priority lines, assistance with luggage and escort service to the car or departure gate.
- b) Advanced booking required: at least 24 hours for domestic flight and at least 72 hours for international flight prior to the schedule meeting time.
- c) Booking is to be done via calling HSBC Premier Concierge (24/7), as mentioned in article 2.2.3. Eligible customers will not be granted access rights to fast track service at participated airport when booking directly with the airport.

- d) Amendment and cancellation must be made via HSBC Premier Concierge (24/7), as mentioned in article 2.2.3 and minimum 72 hours before the schedule meeting time shall be acceptable.
- e) In any circumstance of amendment or cancellation because of the airline company, booking shall not be count as a completed redemption if Eligible customer could provide the related document shown that the amendment or cancellation from the airline company. In case Eligible customer would like to arrange the schedule meeting again, it requires at least 72 hours to re-arrange and subject to the availability of the service.

#### 2.4 Other provisions:

- 2.4.1 The redemption code(s) will be invalid after expiration date.
- 2.4.2 If customers have any concerns relating to the Program, they can contact HSBC Premier Customer Services Hotline via (84)28 37 247 666 or customer's Premier Relationship Manager for further assistance.
- 2.4.3 The decision of HSBC on all matters relating to the Program are final, conclusive, and binding and no notification will be sent to customer.
- 2.4.4 The Terms and Conditions of this Program can be changed from time to time at HSBC's discretion. Changes, including decision on program termination (if any), will be notified, registered in accordance with the law and updated on HSBC's website before the effective date.
- 2.4.5 HSBC is not a product/service provider. These products/services are provided by the respective providers under such terms and conditions as determined by that provider. And HSBC accepts no liability whatsoever in connection with such products/services. The products/services are not certified by HSBC and under no circumstances should any product/service be included in this Program will be construed as an endorsement or recommendation of the product/service by HSBC.
- 2.4.6 Inquiries and complaints related to products and services offered in the Program will be addressed in accordance with the provisions of the supplier of that product or service.
- 2.4.7 For disputes arising in connection with the Program, HSBC will resolve in the spirit of cooperation with customers. Any dispute remaining unsolved will be settled in accordance with the laws of Vietnam.
