

TERMS AND CONDITIONS**“SPECIAL OFFER AT CGV
WITH HSBC VISA PLATINUM CREDIT CARDS”**

(This Terms and Conditions takes effective from 09/02/2021)

1. The “**Special offer at CGV with HSBC Visa Platinum Credit Cards**” Promotion (“**Promotion**”) shall be effective from 9/2/2021 to 31/12/2021 (“**Promotion Period**”).
 2. Promotion is applicable to customers who meet all the following requirements (“**Eligible Cardholders**” or “**Cardholders**”):
 - HSBC cardholders who are holding the HSBC Visa Platinum Credit Cards issued by HSBC Bank (Vietnam) Ltd. (“**HSBC**” or “**Bank**”) in Vietnam - (These credit cards shall be referred to as “**HSBC Credit Cards**” or “**Cards**”)
 3. **This promotion is not applicable to**
 - Cardholders if their card is delinquent, or blocked.
 4. Cardholders whose cards are not yet activated will have to activate their Card prior to making purchases.
