



## TERMS AND CONDITIONS

# **“BUY 2 CGV MOVIE TICKETS VALUE VND 100,000 WITH HSBC VISA LIVE FREE CLASSIC CREDIT CARD”**

*(This Terms and Conditions takes effective from 08/04/2022)*

Customer is advised to note that participating in the Promotion or accepting the promotional benefits offered by the Promotion means that Customer has read, understood and accepted these Terms and Conditions.

1. The Promotion **“Buy 2 CGV movie tickets value VND 100,000 with HSBC Visa LiveFree Classic Credit Card”** (**“Promotion”**) is applied at CGV and valid from April 8, 2022 to August 31, 2023 (**“Program Period”**).

2. Promotion is applicable to customers who meet all the following requirements (**“Eligible Cardholders”** or **“Cardholders”**)

2.1 The Promotion is applicable to HSBC Visa LiveFree Credit Cardholders issued by HSBC Bank (Vietnam) Ltd (**“HSBC”** or **“The Bank”**) in Vietnam (, **“HSBC Credit Cards”**) or **“Card ”**)

2.2 Cardholders is CGV member simultaneously.

3. This promotion is not applicable to

3.1 Cardholders who his/her Card is delinquent with fee, balance at HSBC;

3.2 Blocked card for any reason; and

3.3 Cardholders with card yet to be activated will have to activate their Cards prior to making purchases.

4.1 **Offer details (“Offer”)**

- Promotion 1: From Monday to Thursday every week during the Promotion Period, Cardholders buy 2 2D CGV movie tickets (worth VND 160,000) with VND 100,000 everyday but not valid for public Holiday/Tet (**“Promotion Day”**);
- Promotion 2: From Friday to Sunday every week during the Promotion Period, Cardholders buy 2 2D CGV movie tickets (worth VND 240,000) with VND 120,000 everyday but not valid for public Holiday/Tet (**“Promotion Day”**);
- Applicable time: from 9:00 to 23:59 on each Promotion Day during Promotion Period, based on Vietnam GMT+7 and according to CGV's system.
- Total slots for Promotion 1 – “Buy 2 2D CGV movie tickets with VND 100,000” are 700 and apply to the first Eligible Cardholders of each month during the Program Period.

- Total slots for Promotion 2 – “Buy 2 2D CGV movie tickets with VND 120,000” are 2000 and apply to the first Eligible Cardholders of each month during the Program Period.
- Offer only applies to the purchase of 2 movie tickets at the same time in 1 payment transaction via CGV's website at [www.cgv.vn](http://www.cgv.vn) or on CGV mobile application and must be paid online by HSBC Visa LiveFree Classic Credit Card.
- During the Promotion Period, Each Cardholder can only redeem up to 01 Offer in 30 days (based on the day that Cardholder redeemed the offer)

4.2 Eligible Cardholders may not redeem the offer if the number of offers distributed during the Promotion Month has been exhausted.

**5.2** Eligible Cardholders to book 02 2D movie tickets.

**5.3** At payment, Eligible Cardholders select “Partnership Payment”, tick “Buy 2 CGV Movie Tickets Value VND 100,000 With HSBC Visa Live Free Classic Credit Card”.

**5.4** Eligible Cardholder keep making the payment by HSBC Visa Live Free Classic Credit Card, Eligible Cardholder will pay for 2 movie tickets with Promotion price.

6.1 The discount cannot be converted into cash or cash back into any credit card account or transactional account of the Cardholder.

6.2 Purchases at CGV will be subject to terms and conditions of CGV.
